CHAPTER I

INTRODUCTION

In this chapter, the researcher would like to present the introduction of this research consist of background of study, research problem, research objective, assumption, hypothesis, significance of study, scope and limitation, and definition of study.

A. Background of Study

Speaking is an activity of giving speeches and talks to communicate with people. Speaking is one of the most important skills of all the four language skills in our daily life and it is one of the abilities that are needed to perform a conversation. Without speaking, we cannot communicate properly. But, in another case, speaking is not easy for the students who learn foreign language especially English learners.

In foreign language learning, ability to speak is the most essential skill since it is the basic for communication and it is the most difficult skill. Another reference stated that speaking English is the most difficult for learners. In particular, English learners often stammer when speaking English. This results from learners' lack of exposure to authentic English language environments that allow them to use English for communication and expression.² In another side, Language learners sometimes evaluate their success in language learning based on how well they have improved

Grammar is the way that words can be put together in order to make sentence or the way in which they obey the rules of grammar when they write and speak.³ In other word, based on Goold Brown in the grammar of English grammar, grammar, in itself, is the art of reading, writing, and speaking the English language correctly. It implies, in the adept, such knowledge as enables him to avoid improprieties of speech; to correct any errors that may occur in literary compositions; and to parse, or explain grammatically, whatsoever is rightly written. To speak is to utter words orally, in order that they may be heard and understood.⁴

Grammar is crucial in learning English as foreign language. In this case, grammar guides the students in constructing English sentence to communicate with other people. Grammar is bounded to other language skill like listening, speaking, reading, and writing. Good speaking requires

B. Research Problem

John W. Creswell state that research problem is the educational issues, controversies, or concerns that guide the need for conducting a study.⁶ Research problem is to state the explicit question, direct or indirect question that should be answered in the research objective.⁷ In conducting research, the research problem is needed as an important thing in determining the direction of research.

C. Research Objective

Sugiono said in his book that research objective is different with the purpose in the cover of thesis but the research objective related to the purpose of research. The research objective is accordance with research

- To measure the significant of the correlation between students' speaking accuracy and their grammar mastery at Al-Falah English Centre (AFEC) Dempo Barat Pasean.

D. Assumption of Study

Assumption is the researcher's belief, means that she must believe the relationship between the two variables exist and can be discovered by her.⁹ Therefore, the researcher proposes an assumption that students' speaking accuracy and their grammar mastery at Al-Falah English Centre (AFEC) Dempo Barat Pasean have a correlation.

E. Hypothesis of Study

Hypothesis is statements in quantitative research in which the researcher makes a prediction or a conjecture about the outcome of a relationship among attributes or characteristics.¹⁰ Because hypothesis is a prediction, the truth should be proved by collecting and analyzing data of study.

The researcher proposes two hypothesis, namely Null hypothesis and Alternative hypothesis. They are as follow;

- 1. Null hypothesis (H_0): There is no correlation between students' speaking accuracy and their grammar mastery at Al-Falah English Centre (AFEC) Dempo Barat Pasean.
- Alternative hypothesis (H_a): There is correlation between students' speaking accuracy and their grammar mastery at Al-Falah English Centre (AFEC) Dempo Barat Pasean.

From the two hypotheses above, researcher tends to use alternative hypothesis (H_a) because the researcher believes that there is correlation between students' speaking accuracy and their grammar mastery at Al-Falah English Centre (AFEC) Dempo Barat Pasean. Such as in previous study, the thesis by Zahrotun Nisa' found that there is correlation between students' grammar ability and their speaking skill and the research by Zahrotun Nisa' had proven by statistics significant.

The researcher's reason is that the students who have master of grammar will be easier to speak English and make them speak accurately because grammar mastery impact to the student bravery and also make them speaking accuracy.

F. Significance of Study

Significance of the study states the implications of the findings for educational practice and theory. ¹¹ This study has two significances. Those

For further research, this research may be useful references for further researchers in the same field especially in students' speaking accuracy and their grammar mastery.

G. Scope and Limitation

In this research, the researcher has scope and limitation of research. Scope is range of things that a subject, an organization, etc deals with. 12 While limitation is potential weakness or problem of study that are identified by the researcher. 13 In another reference, limitation is act of limiting or controlling. 14 This section the researcher wants to focus to the object observed. Understanding about the scope and limitation of the study of the researcher.

- The scope of this research is the correlation of students' speaking accuracy and their grammar mastery on Tense (present tense, Past tense, present continuous, future, present perfect continuous, present perfect tense, and future continuous,)
- This research is limited only for member of Al-Falah English Centre (AFEC) Dempo Barat Pasean.

H. Definition of Study

Creswell suggests us to begin our research by narrowing our topic to a few key terms using one or two words or short phrase.¹⁵ This section describes the terms used so that there are similarities in interpretation and avoids the obscurity of meaning.¹⁶ The definition key terms need to be explained based on the terms that related to the point of concept in the research.
