CHAPTER I

INTRODUCTION

A. Research Context

Speaking is one of language skill which is very important to be good in communication. Muzayyanah in her thesis stated that speaking is a part of social interaction which is very important to make a relationship with others.¹

In learning speaking skill, students should more practice to be able to speak in the English language. Having spoken English much time will help students to be fluent, by practicing it students are able to improve their ideas, grammar and also improve new vocabularies and pronunciation that are needed in speaking skill.

To achieve the aim of teaching English, especially speaking the teacher use individual presentation technique to make the students' activities run effectively. Presentation is a communication activity to convey information in front of many peoples (audience). While the individual is an adjustment of one's self, in which a person is formed in his own personality.

MA Miftahul Qulub Polagan GalisPamekasan is an Islamic Senior High School which concerns with students' speaking skill. The teacher uses individual presentation in teaching speaking of English. She said that many learning methods applied at this school included question and answer dialogues, to discussion methods. With the aim of course to improve students' ability of communication,

the results have not been satisfactory. The teacher keeps trying to implement another teaching technique, namely individual presentation. It seems there is a good result in using it, she keeps implement it until now.²

Individual Presentation is defined as a process in which an individual sends stimuli to change the behavior of other individuals. Ervin Goffman (1959) states that individuals called actors present themselves verbally and non-verbally to others who interact with them. Individual presentation or often also called impression management (impression management) is an act of self-presentation performed by each individual to achieve an expected self-image. 4

A good presentation will occur where the individual as a communicator makes the audience understand the material presented. So, the audiences are inspired to determine/choose the best step. Poor presentations occur where individuals as communicators are not able to explain the message (only understood by themselves) so the audience does not understand the message it receives.

Some studies in individual presentations were carried out by some researchers. The first, a previous study entitled "The Implementation of Presentation Technique for Speaking Skill at The Third Semester Students of DEE UMS in SEGA Extracurricular Program" by Wahid Prasetyo argues that: 1) Presentation is attracted to be implemented to deliver the argumentative speaking

to the third grade of undergraduate students in SEGA DEE UMS.2) The use of presentation is more difficult than other methods in teaching speaking.⁵

The second, "Social Media and Self Presentation" by Jandy E.Luik argues that in presenting themselves, users must adjust their appearance with a variety of strategies: 1) Ingratiation 2)Competence 3) Intimidation 4) Exemplification 5) Supplication.⁶

The third, according to Gavin and John in their journal "Using Oral Presentation to Improve Students' English Language Skills" they have found that presentation can be student centered, meaningful activities that students enjoy doing. They could see the students in the classes become more active learners and learn to enjoy taking part in creating their own content for the class.⁷

Based on the explanation above, the researcheris interested in researching more about "The Implementation of Individual Presentation in Teaching Students' Speaking Skill at Twelfth Grade MA Miftahul Qulub Polagan Galis Pamekasan"
