#### **CHAPTER I**

#### INTRODUCTION

In this chapter, the researcher would like to discuss about research context that tell us about the phenomena in problems of study, research focuses tell about the focus of the problem in research, research objectives tell about the aims of the researcher, significance of study tells about the benefit of the research, such us for the researcher, the students, the readers, etc. the scope and limitation of the research that make the research have the main problems of the research and definition of key terms tell about the explanation of the title of the research based on the researcher perspectives.

#### A. Research Context

Reading is one of the skills of English. Reading is an important skill for the success of the language learning. MoslehHabibullah said that reading is a good thing for language students and at the very least, some of the stick in their minds as part of the process of language acquisition. Considering those previous research, the researcher make the specifying of the students technique. This research focuses on students techniquethat used in learningreading subject. It causes the technique is one of way to help the students more interested in reading texts so that the students can enjoy reading texts Besides, the researcher takes the object of the research at third semester in the English education program of IAIN Madura.

English education program is one of the departments in IAIN Madura. Almost every year, the students of this department rise. It can be called that this department is one of many favorites department in IAIN Madura. In the 2020 generation, actually in the third semester, there about four classes, namely A, B, C, and D class. In every class, there are about 27 to 30 students. This research only focuses on the English education program because the English education program, especially in the third semester, has a reading subject. The researcher chooses the topic because in the English teaching learning process most of the students thinks that online learning not effective, not focus because there are other notifications in their phone that disturb them to study especially in read a

text, got bored and also lost their interest in reading, especially in reading English texts.
