

CHAPTER I

INTRODUCTION

Researched by Nining Indah in the title “ The Use Of Whatsapp Application To Teach Writing Recount Text “ The purpose of this study was to find out the easiest technique for teaching English writing using Contextual Techniques Using the WhatsApp application for tenth graders at PGRI 5 Sidoarjo. So that students are not monotonous in learning because it will affect the mood of students to learn. This study uses a qualitative descriptive method
