

CHAPTER I

INTRODUCTION

In this chapter, the researcher will describe the introduction consist of research context, research focus, research objective, significance of the study, scope and limitation, definition of key term, and previous study.

A. Research Context

The etymology the word pattern comes from the Latin word ‘patronus’ meaning ‘defender’, advocate, model. In english the word eventually became ‘patron’ meaning ‘a model to be imitated’. This is where the modern mening of the modern meaning of the word pattern is devired from.¹

Patterns are models, examples, guidelines (drafts), the basis of work.² A pattern is a form or model (or more abstract of a set of rules) commonly used to create or to produce a thing or part of an arising simply having one type, for an archetype that can be shown or seen where something is said to exhibit a pattern, the detection of archetypes is called pattern recognition.³

According to the Colin English Dictionary, the pattern is, 1. Arrangement of lines, shapes. 2. When in which something happenes or is aranged. 3. Design or instruction from which something is to be made. 4. Use something/somebody as a model for something/somebody.

Etymologically or the origin of the word, the term communication comes from the Latin communication which means comes from the word communis which means the same, namely the same meaning about something. So communication takes place if between the people involved there is a common meaning about something that is being communicated.

Terminologically, communication means the delivery process a message from one person to another. So get involved in communication is human or in a foreign language called Human Communication. Communication discussed here excluding animal communication, transcendental communication and physical communication.⁴

In general, the communication is the process of sending and receiving messages or information between two or more individuals in an effective way so that the intended message can be understood. The pattern of communication is the way an individual or group communicate. The pattern of communication in this paper is the way a group or individual works in communicating based on communication theories in conveying messages or influencing the communicant.⁵

An understanding of this pattern can be illustrated as when we will make clothes. When someone is going to make clothes he will make a pattern or often called a pattern, this pattern is flexible and easy to change. This pattern will determine the shape and model of a shirt, then after going through several

Education is the sense of law number 20 of 2003 is referred to as a conscious effort and planned to create an atmosphere of learning process so that students actively develop their potential to have religious spiritual strength, self-control, personality, intelligence, noble character, as well as the skills needed by himself, the people of the nation and state.⁶ Education in essence is to build a nation's civilization through developing human beings as a whole.⁷

Learning by utilizing information and communication technology takes place not only in a place like here school, but it can be done in many different places. Learning does not only consist of one person, but many involve people. Every learner can learn at any place and time different ones. How to learn from an unlimited learner with time and place that is called information and communication technology-based learning. For this reason, learning models such as computer based learning were born which gave rise to distance learning.⁹

Utilizing information and communication technology in interdisciplinary learning other with: 1. Teachers and learners are able to access information technology and communication. 2. Teachers have knowledge and skills in using information and communication technology, because the teacher acts as a learner who must learn continuously throughout life. The goal is to improve their professionalism and competence. 3. There are quality and meaningful learning materials available.¹⁰

However, in 2020 Indonesian was shocked by the arrival of new virus known as Covid-19 which originated in the city of Wuhan China. The impact of Covid-19 in Indonesian has had a huge impact on the entire community. On March 24, Ministry of education and culture (Kemendikbud) Nadiem Anwar Makarim published circular number 4 of 2020 concerning the implementation of education in the emergency period of Coronavirus Disease (Covid-19). This is to strengthen this circular, the ministry of education and culture (Kemendikbud) issued a circular number 15 of 2020 concerning guidelines for organizing learning

from home in an emergency Coronavirus Disease (Covid-19). The Covid-19 pandemic requires educational institutions to carry out the learning process by conducting distance learning or online learning.

Therefore, education is carried out online using the help of learning media during the Covid-19 pandemic. Media on of supports is learning process. Success and failure of the learning process is largely determined by the media used. Media is anything that can be used to transmit messages from sender to reciepiant so that it can stimulate student thoughts, feelings, attentuion, and interests in such a way that the learning process occurs.¹¹ Online learning is an open learning system and distibuted using pedagogical tools (education aids), made possible thought the internet and network based technology to facilitate the formation of learning and knowledge processes thought meaningful action and interactions.¹²

Online learning media can be interpreted as media that is equipped with with operable controller by the user, so that the user can control and access what into user requirements, for example download resources for materials Tenses in English lessons. Advantages of using learning media online is self-directed learningg and high interactivity, able improve memory level, give more learning experience, with textt, audio, video and animation are all used to convey information, and also provides ease of delivery, update content, download,

students too can send e-mails to other students, post comments on discussion forums, using chat rooms, to video links conference to communicate directly.¹³

Offline learning usually done face-to-face but now during Covid-19 school is done online. Teachers and students carry in different places or their respective home by communicating Goggle Classroom, Zoom and WhatsApp in learning english. In the process of learning online the teachers gives assignment to student such as doing task. therefore, in some cases, the internet is used to complement teaching, such as in the use of website to convey information to students who are in face-to-face classes. The term online information is also used to describe any courses that is delivered to students who are not present in the same room.¹⁴ Offline learning media can be interpreted as media that is not equipped with a controller/navigation device that can used by the user. this medium run sequentially (in sequence). For example, the general percentage media not equipped with tools to control what what the user will do. Percentage runs sequentially as a straight line so that can be called linear media and usually used when the number of audience is more than one people, for example can be realized in CD form.¹⁵

English learning pattern is to incerease students self-confindence as a positive effect of reducing student anxiety so that students activeness in the

For example, the media used in online learning at SMP Plus Nurul Wisdom such as the WhatsApp application, Google Classroom, Google Meet and Visual Video. All forms of subject matter and

F. Previous Study

Reseacher found a study written by Serkan Kaymak entitled, “Comparison between offline learning and oline learning” This study tells about to see whether there is a significant difference in students' achievement between online and offline modes of instruction. Problems about A total of 62, 7th-grade students from Nurorda school in Nur-Sultan, Kazakhstan, chose their preferred instructional method, 39 students choosing offline studies and 23 students selecting online studies.

The research used is quantitive research as an effort to answer the problems. The similarity of this research with the research that will be carried out by researchers conducting research on online and offline learning, while the difference in this research is location study by the researcher.

Another research that conduct by Fiqhi Liesdistiana Damayanti “Effectiveness Of Online Vs Offline Classes For Efl Classroom: A Study Case In A Higher Education.” This study tells about investigates common student perception of the online lesson as compared with offline lessons to indertify the effectiveness between online and offline class. The result, more students associated in-class lessons. They felt more interest, due to better understanding, classroom interaction with the lecturer and student, and enjoy during the lesson. The student prefer to the offline larning than online learning.

The similarity between previous study above and the present study is both of them is focus on learning online and offline. The diffences of this

research is the previous study chosen from Higher education. While in the present study researcher conducted research eight grades of SMP Plus Nurul Hikmah Pamekasan. Another previous study used quantitative approach and present study used qualitative approach.

Another research that conducted by Padmalini Singh “A Comparative Study on Effectiveness of Online and Offline Learning in Higher Education.” This study tells about investigate the effectiveness of online and offline education in higher education. The result indicated that the effectiveness of online education is dismal, as students find it difficult to adjust to the online mode of education and the offline mode of education remains the most preferred mode of education. The research used is quantitative research.

While Another research that conducted by Shai Ben David “Online Learning Versus Offline Learning” This study tells about compare the number of mistakes made by the offline learner on certain concept classes to those made by the online and self directed learners. the difference is research used quantitative approach and location study and the similarity of this research with the research that will be carried out by researchers conducting research on online and offline learning.

While researcher found a study written by Resy Muryati entitled, “Proses Pembelajaran Daring/Luring Pada Masa Pandemi Covid-19 Di Kelas I Madrasah Ibtidaiyyah Nurul Ittihad Kota Jambi.” This study tells about the many complaints report by parents about the obstacles online learning. Problems about

complaints from parents cause teachers or school to need to find solutions to overcome the problem.

The research used is qualitative research as an effort to answer the problems that have been stated because of its nature using a descriptive analysis approach. The similarity of this research with the research that the researcher will do is carried out online and offline, while the difference in this research is location study by the researcher. The data collection uses observation, interview, and documentation.
