CHAPTER I

A. Research Context

Launched in 2005 by three young men in California, Youtube had become a popular site. Founders Steve Chen, Chad Hurley, and Jawed karim had developed Youtube as a means to share videos quickly and easily, and they encourage users to broadcast

In this study, it found that there was advantages and disadvantages in using

YouTube as a medium of learning in the Public Speaking class. ¹⁴The difference between previous studies and this research is that previous studies discussed "The Use of Youtube as Teaching Media in Public Speaking Class: Students Perception" which focused more on the use of Youtube as a medium in public speaking classes. While in this research, the researcher discusses "The Student's Perception on Youtube as Media in English Learning at Eleventh Class of MA Tariqat Shufiyah Palengaan Pamekasan".

Another research was also researcher by Rahmi Akmal Hussin, Sofyan A. Gani, Asnawi Moslem "The use of YouTube media through group discussion in teaching speaking". This study at finding out whether the use of YouTube videos through group discussion assisted students to improve their speaking skills (pronunciation, grammar, vocabulary, fluency and comprehensions). Rahmi Akmal Hussin research used a qualitative method with experimental design. The results of this study showed that using YouTube videos through discussion group assisted the students to improve their speaking skills, with the most significantly improved skill was comprehension. The similarity between previous research and this research is the both of this study conducted research on the use of YouTube as a learning medium. The difference between the
