The previous study was consucted by Lailatul Isnaini is a problem about understanding the long text makes students tired and stops reading. Especially some of students of Al-Amien consider that the reading material is difficult and the sentence complex accompanied by foreign vocabulary makes it difficult to understand, the front size layout tends to monotous so it doesn't getunderstanding. So the teacher pays more attention in providing the appropriate reading material for the students and she was used quantitative method.⁵

In the teaching learning process, readability problems ecountered in the textbook that are used to have difficulty of understanding foreign vocabulary and the length of sentences presented makes the difficulty level of textbook very high. The teacherefforts so far have been sorting out reading material to provide material by considering readability to students without overwhelming them. So, the effort of the teacher in theacing learning process are very important with creative ideas able to provide direction so that students can easily understand the reading material provides by the teacher.readability is one factor determines his or her success in reading.
