#### **CHAPTER I**

#### **INTRODUCTION**

This chapter provides some points dealing with the tittle of this thesis. In the other words, the researcher will introduce the study from the beginning points. It consists of six over all sub chapters. They are background of the study, the research focuses, the research objectives, the significance of the study, the scope and limitation, and the definition of the key terms.

## A. Background of Study

Literature is one of work from human that they need in their life. Literature is simply another way that we are able to experience the world around us through our imagination.<sup>1</sup> Literary work is used by human to express and share to the readers about feeling, ideas, experience, ambition and imagination. By reading literary work, the readers will get knowledge and experience. As a creative product, it is able to set the readers to become one with the literature itself. Literature is able to make people feeling the situation, emotion and many things that are written in the literary work.

There are many kinds of literature, as like; drama, poetry, song, novel, prose, journal, newspaper, etc. They relate to language. Some of them prefer to fiction. They have their own language style to interest many people. One of the literature is novel. Fiction is the truth of novel and it is included in literary work.

The novel is one of story plots which is more complex or not a pattern of even about the human being, their feeling, action and observes human life.<sup>2</sup> It reflects the condition and situation of human in real life that is illustrated by the author of the novel in written form. The novel is not only about the imagination of the author but also describe the reality and also sometimes it is related to the author's experience.

The novel is telling about the story, plot, character, characterization, theme, conflict, point of view, setting, moral value and other elements.<sup>3</sup> When reading the novel, the reader certainly will not separate from the conflict. Conflict and moral value or ethics are important. The author certainly makes interesting something in order to make the reader interested in their work. Without conflict, the story will not interest to the reader, because conflict is something dramatic. Almost all readers often find internal and external conflict in every novel.

A conflict does not come by itself. But, it happens because a condition of an object that created conflict itself.<sup>4</sup> By including the event and the character's action, a conflict will be growing up. Character is important in the novel. Because they will be told in the story itself. They will describe their activities with all conflicts that happen for all of them, especially for the main character.

Besides that, if we talk about the content of the novel, According to William Kenney states that moral value or the ethic form the novel we

usually mean peace of rather practical moral advice that is able to be derived from the story.

In this case, the researcher is interested in fiction or novel. The researcher decided to choose Islamic/ Religious romance by Hamka as a study. There are many reasons why the researcher chooses the novel by Buya Hamka. Firstly, the researcher thinks that this novel is very unique and interesting novel than others. Because the writer of this novel (Buya Hamka) is a critic of Indonesian literature and Buya Hamka has good intention to criticize some traditions that have done by society at the time, especially about "Forced marriage". And since this novel was published it has continued to experience reprinting until now and has become mendatory reading material for school students in Indonesia and Malaysia. Secondly, the researcher thinks that by reading it, the reader will know the Islamic ethics or moral value contained in the novel and the researcher is able to judge the value in the novel itself. Thirdly, the researcher will know more about the perspective literature in this novel, so the researcher will know about the element of the novel. Fourth, the researcher thinks that by studying the Islamic ethics or moral values in the novel is a very important thing and it is relevant with the attitude and how to be a good people or educates people in this era. While we are as human we should have a good attitude and also we are as Muslim we should increase our behaviour include in attitude to be better than before. From this explanation above, it has explained in Al-Qur'an and Hadits.

In Al-Qur'an, Allah said

وَإِنَّكَ لَعَلَى خُلُق عَظيمِ

The Meaning is

"Dan sesungguhnya kamu benar-benar berbudi pekerti yang agung".<sup>6</sup> "And indeed you are above the great morality".<sup>7</sup>

In Hadits:

إنما بعثت لأتمم مكارم 8

# الأخلاق

The meaning is

"Dengan cara ini, saya menciptakan dia (Muhammad) karena menyempurkan akhlak" (HR. Ahmad, Bukhari).<sup>9</sup>

"In this way, I created him (Muhammad) because of perfecting morals"

(HR. Ahmad, Bukhari).<sup>10</sup>

This verse shows us about the ethics or the moral that the Muslim should improve all of them to be better. From Al-Qur'an and sunah or Hadits above, our God has said that our prophet Muhammad SAW has a good attitude or moral and hopes that we are as Muslim imitate what have done by our prophet. It is included in the activity and his behaviour. In the novel of Tenggelamnya Kapal Van Der Wijck, it related with the research

that will find out the Islamic ethics that contained in the novel of Tenggelamnya Kapal Van Der Wijck and could get many lessons related with the Islamic ethics contained with the novel itself. And then, after the readers try to understand about the content of the novel, they will study how to applicate the Islamic ethics in their daily activity, to make their behaviour be better than before. It is iclude in attitude, they can study how to be a good people and have a good attitude from read the novel.

According to Fr. Austin Fagothey in Right and Reason traces the origins of ethics from the Greeks. Ethics is therefore, a study of right and wrong in human conduct and ethics can also be defined as a theoretical examination of morality and as an equivalent of the "theory of morals". The word "Ethics" comes from an ancient Greek word Ecbi which means character.<sup>11</sup>

In this fiction, the author creates it with romance especially in the religious or Islamic, because the conflict that happens in the novel of "Tenggelamnya Kapal Van Der Wijck" relates with the Islamic Ethics or moral value and Buya Hamka wants to criticize the culture in the content of this novel that is not appropriate with Islam.

Prof. Dr Hamka or Haji Abdul Malik Karim Amrullah is one of the most relevant figures in the provision of thoughts within the society and he is the author from Indonesia that is very famous in Archipelago.<sup>12</sup> He was born on February 17, 1908, in Maninjau, West Sumatra, Indonesia. His

Buya Hamka is success to create this novel to be the best seller and improve the content of the novel itself to be one of the literary work that is included in the unforgettable story.

The readers will be curious of the novel in Tenggelamnya Kapal Van Der Wijck, exactly about what happen in the content of this novel, it is include in the perspective of the novel. Because there are many problems that happen there, the plot of the story and the situation that happen both of the character in the novel. So, it is one of the reason why the readers and also the researcher interest in it. While, this novel told about the struggle about love that can not be reached. Because the characters of this novel comes from different background.

# **B.** Research Focus

#### C. Research Objectives

According to Creswell, research objective is an intent statement that is used in qualitative research, the goal is specific with the planning of the researcher that is called by objective study.<sup>16</sup> Research objectives should be stated differently from the research problem, as the research are
