CHAPTER I

INTRODUCTION

In this chapter, the researcher will discuss about research context, research focus, research objective, significant of study, scope and limitation of study and definition of key terms.

A. Research context:

In learning English language students should comprehend four skills, they are: speaking, listening, reading, and writing. Writing is one of language skills which needs more practice. It is a complex and time consuming process.¹

The goal of teaching learning at junior high school is that the student must be able to develop communicative competence in written as well as in spoken to achieve functional literacy level. They are expected to be able to communicate both in spoken and written form to solve problem in their daily lives. The English material is tough based on the text.

Some students know or have the ideas what they are going to write, but they do not know how to put them into words. They cannot build a good sentence. Many students could not express their ideas in written form, although they may know what will be written. Most of students are also not able to construct sentences in past tense and arrange the sentences coherently.

So many students could not express their ideas even though they have been given a topic to write.

Writing is a complex process that the writers can express the ideas in their mind to be obviously. With writing can motivated us to think and learn to communicate and to use our mind as a reflection.²

If someone uses a second language to speak, a native speaker can understand and accept the word that is spoken even though it is less than perfect. However, if a student uses a second language to write, native speakers will appreciate many spelling or grammatical errors.

Grammar is one of the English micro skills that every learner needs to achieve. Grammar teaching is too important to be ignored, and that without a good knowledge of grammar, learners' language development will be severely constrained.

Verb name an action or describe a state of being. Every sentence must have a verb.³ Verb is a word that expresses action or otherwise helps to make a statement. All verbs help to make a statement. Some help to make a statement by expressing action. The action expressed maybe physical, as in the case of such verbs as hit, play, blow, and run, or it may be mental, as in think, know, imagine, believe.⁴

Recount is a text which retells even or experiences in the past. It purposes is either to inform or to entertain the audience. So, recount text is a

kind of text that tells the reader about someone's experiences or event that happen in the past.

The error is mistake or the accident was due to human.⁵ Students sometimes feel confused in writing recount text, their confusion is in the verb changes. In MTs Riyadul Ulum Bicorong Pakong some students in writing the recount text still use verb one. And sometimes students find it difficult to distinguish between the use of regular verbs and irregular verbs.

In the previous study by Ainun Arifah, she gives information about the analysis of spelling error on writing recount text at tenth grade students of MA Al-Amien 1 Pragaan. Her data focus on the spelling error made by students when they wrote the example of recount text. In her research, she analyzed the factors behind the spelling error which is made by the student on writing recount text.

In the previous study by Lisca Purwati, she gives information about the grammatical error of complex sentence to compose recount text among the students of writing skill at SMP Negeri 8 Pamekasan. Her data focuses on the use of complex sentence made by the students when writing the example of recount text and also found the factors behind the writing error which is made by the students on writing recount text.

The researcher want to conduct a research about an analysis of changing verb on writing recount text at 8th Grade in MTs Riyadul Ulum
